Mixed Doubles Tournament Rules

1. **Eligibility:** Participants must be certified members of the Rochester NY USBC Association and bowling in a current certified league. Teams consist of one man and one woman.
2. **Entering average:** Highest certified average for 21 games or more for the 2017-18 season. USBC rules 319a.2 and 319e.2 (10- and 15-pin increase provisions) are waived.
3. **Format:** The tournament consists of three (3) games bowled on one pair of lanes. Tournament management assigns lanes as entries are received. Entrants wishing to bowl together must submit entries together.
4. **Prizes and Awards:** All prize fees will be returned (100%). Cash prizes are awarded on a handicap basis in both divisions. *You may cash more than once by changing partners.* First place team winners each receive a plaque and an invitation to the Awards Banquet. Additional “out of money” individual scores are paid.
5. **Prize Ratio:** Based on at least one award for every six entries.
6. **Award Criteria:** Total pins plus handicap for three games determines prize winners.
7. **Exceptions:** If no prior average is established, participant must enter tournament with their highest 2018-2019 average as of start of tournament (minimum 12 games). Bowler must provide Tournament Management with their league standing sheet *before* bowling. Sport and challenge averages will be adjusted according to current USBC rules. Bowlers with *no* average bowl scratch.
8. **Check-In Procedure:** Entrants are requested to report one-half hour prior to the scheduled squad time. Bowlers are required to present their current USBC membership card.
9. **Unscheduled Walk-Ins:** Call the bowling center to check for lane availability and please be there ½ hour prior to the scheduled squad time.
10. **Refunds:** No entry fee is refunded. Substitutions permitted subject to prior arrangement with Tournament Management. There will be a \$30.00 charge for returned checks.
11. **Disputes:** Any disputes will be discussed by the tournament committee and decisions will be made by the tournament director, whose decision is final.
