#### This event is certified by the United States Bowling Congress (USBC).

Any USBC certified tournament rule not specifically stated, waived or modified in these rules will apply to this tournament where applicable.

**ELIGIBILITY** - The Rochester NY USBC Women's City Team Tournament is open to all female members that had a sanctioned average in the Rochester NYS USBC local association for last bowling season and/or current bowling season. The event is conducted under USBC rules and regulations and are required to pay any additional sanction fees. Non-members of the Rochester NYS USBC for the current season, but with a Rochester NY USBC Sanctioned Average the previous season can become eligible by purchasing a USBC membership card for \$21. Tournament is not SMART Certified.

#### **ENTERING AVERAGE used based in the order listed:**

#### Book & League Averages based on Rochester NY USBC Leagues

- 1. 2018-19 Standard/House averages, highest at minimum 21 games.
  - USBC Rule 319 will apply, any bowler whose current average as of January 1, 2020 is 10 or more pins higher than her 2019-20 average and at least 21 games, must use current year's average.
- 2. 2018-19 Sport & Challenge averages, minimum 21 games.
  - A bowler with only averages established on a sport and/or challenge must convert that average to a standard average using the USBC conversion chart and enter with the highest converted average. (Rule 201c)
- 3. Current Season averages 2019-20, minimum 21 games or more as of February 28, 2020.
  - o Highest Standard average or if only Sport/Challenge then highest converted average.
  - Any bowler who will be using their current year 2019-20 average must submit to the tournament director written verification of this average from their league before bowling in this tournament.
- 4. Averages established in USBC Youth leagues will not be accepted.
- 5. Bowlers are responsible for verifying her own average, whether submitted by the bowler or others. Failure to use the proper average or make a correction up to the completion of the end of the first game may disqualify you.

Entry Fees - Mail checks payable to the Rochester NY USBC with entry form to: Rochester NY USBC, 745 Titus AVE Annex, Rochester, NY, 14617. There is **no** refund of entry fees after February 28, 2020.

**Multiple Participation:** A bowler may compete multiple times in the team event with at least two bowlers on the team being changed. The Bonus Singles may be entered multiple times but cash only once with the highest score.

**Bonus Singles are** paid on series bowled in team event adding Hdcp of 100% of 200. Bowlers will be placed in divisions by their own average. *Additional sign-ups are available at check-in.* 

Substitutions: All substitutions must be reported to the Tournament Director at time of Check-In or prior.

After a game has started, a substitute, if one is available, is allowed in case of emergency. When a substitution is made during a game, the score of such game shall be credited to the starting bowler. Only the actual score of the frames bowled shall count if a substitute is not available. No blind scores are used when a bowler does not show and a substitute is unavailable. Bowling frames lost may not be made up. No pins allowed for lost frames.

**Physically Disabled:** Disabled bowlers requiring aids such as crutches, canes, wheelchairs etc. or who are blind, must report this in writing when entry is filed so that special scheduling considerations can be arranged. Similar advance notice must be given if such a disabled bowler is to be used as a substitute.

Assigned Lanes: Lanes are assigned. Bowlers wishing to bowl together should state that on the Entry Form.

Additional Squads may be added during the course of the tournament as deemed necessary by tournament management; no squad shall be added after the last advertised squad time.

#### Bowlers are requested to report half hour prior to squad time.

#### \*\*\*\*\*\*

Any protest or appeal affecting eligibility or general playing rules must be confirmed in writing to the Tournament Secretary before the tournament prize payments are made. Errors in scoring must be reported to the Tournament Secretary within 24 hours. The Board of Directors of the Rochester USBC shall have power to hear and act on all protests arising from or under construction of rules in this tournament.

The entrants whose names appear hereon or their authorized replacements hereby agree that the Rochester NY USBC its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting wherefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control; of the Rochester NY USBC.
